DECEMBER 2015 BUDGET LETTER


At the December meeting the Board of Directors completed the budgeting process and approved the 2016 Budgets. The Board would like to thank those members of the community who gave of their time to assist in the budgeting process by being members of the Budget Committee. This year the Budget Committee members were Sharon Briggs, Jerry Grant, Ted Miller, Jeff Stevens and Jay Weber. The Treasurer chairs the Budget Committee. Our community budget actually consists of five separate budgets: General Operating, Townhome Operating, General Reserve, Townhome Reserve and Townhome Water. The dues for Single Family homes contribute to General Operating and General Reserve. Townhome contributions are applied across all five budgets. The budgeting process consists of xxxxx distinct phases. Throughout the year the Board will manage expenditures against the approved budget. In preparation for the Budget Committee meeting the Treasurer working with Hallmark Management will estimate what we believe the balances of the different funds will stand at the end of the year. The Budget Committee will recommend spend to the Board for the following years. Using the end of year balance and recommended spend, the budget committee recommends dues contribution for each of the five funds. The work of the Budget Committee is reviewed by the Board, and is either approved or rejected. This year the recommendations were approved.

Looking at the budgets in a little more detail. A wet spring, which meant less watering and reduced costs to heat the pool, contributed the Operating Budget ending 2015 under budget. For 2016 we have a budget of 579K, almost half (44%) of the budget goes toward the maintenance of our 23 acres of common space. Utilities (trash, water, gas/electric) account for another 27% of the budget. Bottom line there is very little discretionary spending in the General Operating budget. The Board has determined that we want to continue to invest in community outreach and activities including a Grand Opening reception once the remodeling of the clubhouse are complete. The remodeling of the clubhouse will be funded out of the General Reserve. The contributions for all homes to the General Reserve will remain unchanged from last year. While the wet winter and spring was good for our watering spend, it had very negative impact on the amount of shoveling required. The Townhome Operating budget is primarily for winter snow removal and with the snows last spring and the major storms this fall, we are over budget for 2015. After reviewing several options the Budget Committee determined that we would need to increase the Townhome operating budget in 2016 to address the shortfall. This will have a net impact of 5\$ per month on the townhome dues.

As always the budget committee worked diligently to be fiscally prudent while looking to maintain our community. Should anyone wish to assist in the budgeting process next year please contact Martin Garrity or Hallmark Management.

As decided by the Board, effective February 1st, the Townhome dues will be \$131.00 and Single Family will be \$90.

"The Board of Directors is aware that its management company, Hallmark Management, does not have a Community Association Manager license as is required by the State of Colorado. The board is working to resolve this issue immediately and will update the residents as is appropriate."

CALL TO ORDER:	Lynn Countryman, President, called the meeting to order at 7:00 PM. Directors present were: Sharon Briggs, Martin Garrity, Chris Mumfrey (7:49), and Buzz Van Welden, Jay Weber and Bob West. Ron Valiga of Hallmark Management was also present.
COMMITTEE REPORTS:	<p>❖ GROUNDS: Eric Plouffe of JBK was not in attendance. Leaf cleanup will continue, as the weather will permit. Broken tree branches at 8178, 8193, 8121 E. Phillips Circle were removed following the snow storm.</p> <p>❖ CLUBHOUSE: There were 8 uses of the clubhouse, 6 revenue and 2 non-revenue. The Clubhouse renovation plans continue, bids have been received, and a final starting date of 1/4/16 has been approved.</p> <p>❖ ACC: The ACC reviewed 8 submittals. A written report was provided to the Board. The ACC is following up on violation notices that have been sent out. Those who complied with the request have being removed from the "active" list and those who have not are receiving second notices and fines.</p> <p>❖ COMMON AREA PROJECT: The common area project is scheduled to begin in December, weather permitting. Bids on additional areas were reviewed are being contemplated.</p> <p>❖ WEBSITE: A new website has been set up by Bob West. Presently content is being loaded onto the new site and should be ready for the New Year</p> <p>❖ CEN CON: Minutes are available online at cencon.com.</p>
WILLOW CREEK PARK:	Members may visit the South Suburban web site for more information on events.
OPEN FORUM:	A Member was present to discuss ice buildup on the north side of a townhome alley. Another Member was satisfied with the progress of the new web site and thanked Bob West for his technical construction and production of the website.
BUSINESS SESSION:	On a motion by Jay, 2nd by Chris, the minutes of the November 12, 2015 meeting were approved as corrected. A member who had been non-responsive to 4 violation notices was discussed. On a motion by Bob, 2nd by Jay, the matter will be turned over to the HOA's attorney for enforcement. Last month a Member addressed the Board concerning a townhome roofing issue. A metal divider between the two roofs was removed and allegedly not properly blended into the adjoining roof. The City of Centennial was contacted. The City will only inspect roofs if the permit holder requests the inspection. One of the two roofs in question was not permitted, according to the city records. The Budget Committee, comprised of Martin Garrity, Treasurer, Sharon Briggs, Jay Weber, Jerry Grant, Ted Miller and Jeff Stevens made its recommendations to the Board. Martin reviewed the budget on a power point presentation with the Board. On a motion by Jay, 2nd by Sharon, the 2016 budget, which includes a \$6.00 increase in townhome dues, was approved. Bids for common area improvements for rows 8008-8028, 8048-8032, & 8098-8078 were reviewed and approved on a motion by Jay, 2nd by Bob. Jay reviewed the final remodeling plans for the clubhouse that is slated to begin on January 4, 2016. A bid for flowers in the entryway was presented. The bid was tabled and a bid for perennials will be sought. A bid to spray pine and ash trees in the spring was reviewed and approved on a motion by Bob, 2nd by Chris. The 2016 Attorney contract fees were reviewed and approved.



CCSD Students Score Above State Averages On Cmas/Parcc

Tests: Colorado Measures of Academic Success/PARCC results for the Cherry Creek School District outpaced the state averages in all content areas on the tests given in the spring of 2015. The results also mirrored the trends seen in the statewide outcomes. For example, fourth grade scores in English Language Arts in the district and statewide were the highest of all grades and subjects. Eighth grade scores in Math were the lowest. CCSD Board Of Education Sets Annual Mill Levy Rate:

The Cherry Creek School District Board of Education set the mill levy rate for property taxes at their regular meeting Monday, Dec. 14, 2015. Due to TABOR limits the mill levy will decline in 2015 for Cherry Creek from 25.712, to a 2015 base mill rate of 22.494 for the local contribution to the financing of public education. Cherry Creek is one of just three school districts in the state that has not "de-Bruced," which allows school districts and other government agencies to keep tax revenues above the rate of inflation and population growth. That means that despite a large increase in property values in the last few years, residential property taxes in the Cherry Creek School District will increase by just 3.09%, or an average of \$4 per year on an average priced home. In comparison, households in Denver, Jefferson, Douglas and Boulder School districts are estimated to see an increase in property tax averaging from 11% – 15 % (\$14 - \$41) per year.
