Letter from the Board

If summer weather has you thinking about exterior painting, landscaping, roofing, replacing windows, putting in a new driveway or almost any improvement to the exterior of your home, here is some information that may be helpful.

Most exterior projects need approval from the Architectural Control Committee (ACC). To be safe, assume your project is one of those. Our community covenants require the ACC to "exercise its best judgment to see that all improvements, construction, landscaping and alterations on lands within the properties conform to and harmonize with existing surroundings and structures."

A great starting point for project information is our website, WillowCreek3.com. Two pages, "Architectural Control" and "Painting, Roofing & more," contain information intended to help you meet covenant requirements and to move you through the approval process.

On those pages you'll find:

• A link to download the Architectural Control Committee Request Form.

• The email address for the paint coordinator.

• Information the paint coordinator may need from you in order to move forward with paint selection.

• A link to Sherwin-Williams that displays all but four custom exterior paint colors approved for single-family homes. (This Sherwin-Williams link is only a general guide. You must still go through the paint coordinator). • A complete list by address of the exterior paint colors approved for townhomes.

• Colors, styles and manufacturers of approved roofing materials for single-family homes and for townhomes.

• The business address, hours and phone number for the local Sherwin-Williams store.

• Links to the Willow Creek III Covenants and to the Willow Creek III Policies Handbook.

It's important to understand that even if you are using approved paint colors or approved roofing materials, your request still needs to be reviewed by the ACC. However, using the approved choices can make the process move much more quickly.

If you want to use paint colors or roofing materials not already approved, or are planning a project other than painting or roofing, time can be saved if you include with your ACC Request Form a description of the work you will be doing as well as any drawings, samples, photos or literature that will help the committee with its evaluation.

When ready, either submit your ACC Request Form to our property management company, Spectrum Commercial Real Estate Solutions (SCRES), or bring it to an ACC meeting. ACC Meetings are held at 7 p.m. the first Monday of each month at the clubhouse.

If you have questions about your project or don't have internet access, contact Ryan Heath at SCRES (303 409-6030, rheath@ scres.us) or come to an ACC meeting.

Painting a single-family home in WC III?

Before you paint, be sure to e-mail the paint coordinator at willowcreek3paint@gmail.com. Paint colors for the single-family homes must be chosen from an approved palette of colors. Painting a home an existing color is often not acceptable as the spectrum of colors has changed over the years. The ACC works with paint professionals so that the homes in Willow Creek III are current with the prevailing trends. The ACC believes that his enhances the value of homes in Willow Creek III.

Time and again we have all heard that in order to lessen our ecological footprint we should go green" by reducing, reusing, and recycling. But one thing we can do that we don't hear too much about is composting. If you have a yard, you've got a place to start your own composting endeavors. Composting your "green" waste is a great way to improve the health of your soil and decrease landfill waste.

Plant-based food scraps and yard waste, such as leaves and grass clippings, can be placed in a compost pile or bin. Composted waste will then decompose to become nutrient-rich soil that can be added to your yard and garden. Over time and with a little care, your waste can turn into black gold! What's more, anyone can do it, and anytime is a good time to start!

First, determine the type of composter is best suited to your needs. There are several types available for purchase online, i.e., box or tumbler, and many designs are also available if you choose to build your own. While tumblers are easy to use, they are limited in size; most are about the size of a large trash bin. A box composter can be built to any size, but they are more difficult to stir. Once you have your composter in place, it's time to start adding your waste.

What can you compost? Kitchen scraps such as apple cores, watermelon rinds, wilted lettuce leaves, and coffee grounds all make great compost material. Although all kitchen scraps will decompose, it is not recommended that any protein-based scraps such as meat and dairy products be placed in your composter. Protein-based materials attract unwanted animals to your pile and can contain harmful bacteria. A 50/50 mix of brown material and green material is best. Brown material includes dried leaves, straw or hay, wood chips, and wood ash. Green material includes kitchen scraps as described above, clippings from your garden, and grass clippings.

Left alone, "green" waste will decompose and turn into compost, but to speed the process along simply stir your pile and water it occasionally. If you have a tumbling composter this is easy. If you have a box or a heap, a pitch fork or compost aerator will ease the job of stirring. Water the pile so it stays damp, but not wet.

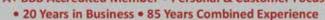
